



ICoCA Membership Update **October-November 2018**

Overview

Since early October 2018:

- The Secretariat has received 2 new industry applications (from DRC and India).
- 2 companies were approved as a Member since October 2018 (from India and Iraq) (in total, 12 companies became Members since January 2018).
- 1 Pakistani company withdrew its Membership in October 2018 after the Ministry of Interior of the Government of Pakistan instructed all Pakistani companies to cease their registration with ICoCA.

Civil Society Organisation (CSO) Pillar

- 30 Members.
 - 6 new CSO Members were approved recently:
 - 2 CSO Members from Iraq were approved in April 2018;
 - 1 CSO Member from the USA was approved in August 2018;
 - 2 CSO Members from DRC were approved in September 2018;
 - 1 CSO Member from DRC was approved in November 2018.

- 7 Members.

Industry Pillar

- 93 Members:
 - ICoCA Certification:
 - 19 ICoCA Certified²;
 - 2 new applications for ICoCA Certification were received in October and November 2018, both of them being approved in November 2018.

¹ 5 companies had their Membership terminated earlier that year for non-payment of the 2017 Membership dues (from the UK, Turkey, Spain, China and Malta. In addition, 6 Pakistani companies withdrew between July and October 2018, 1 company has been in liquidation.

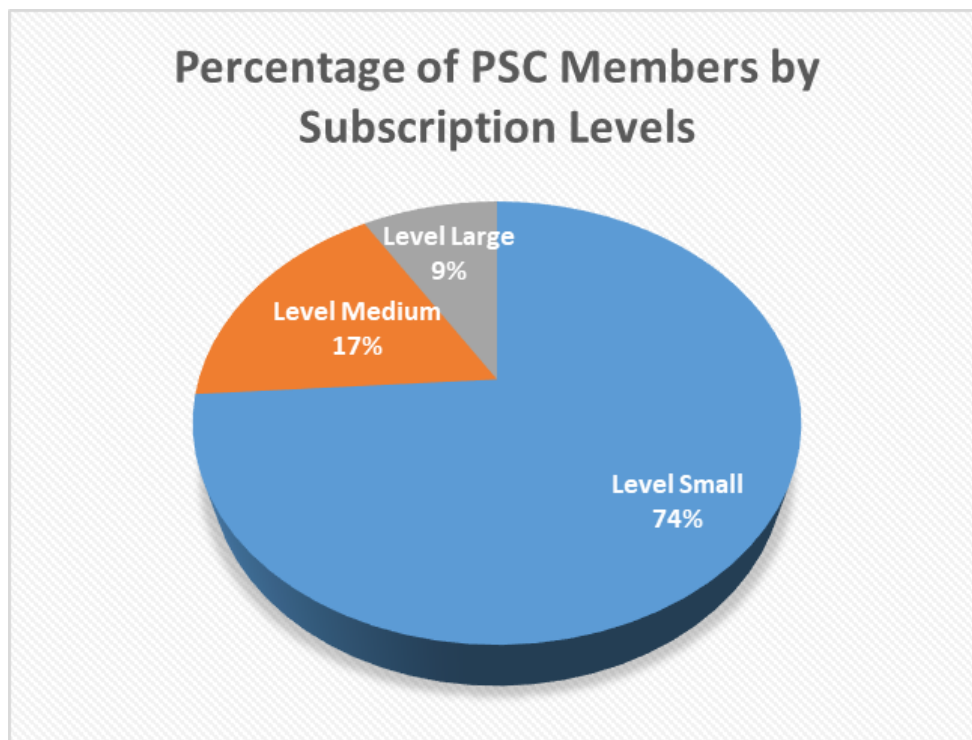

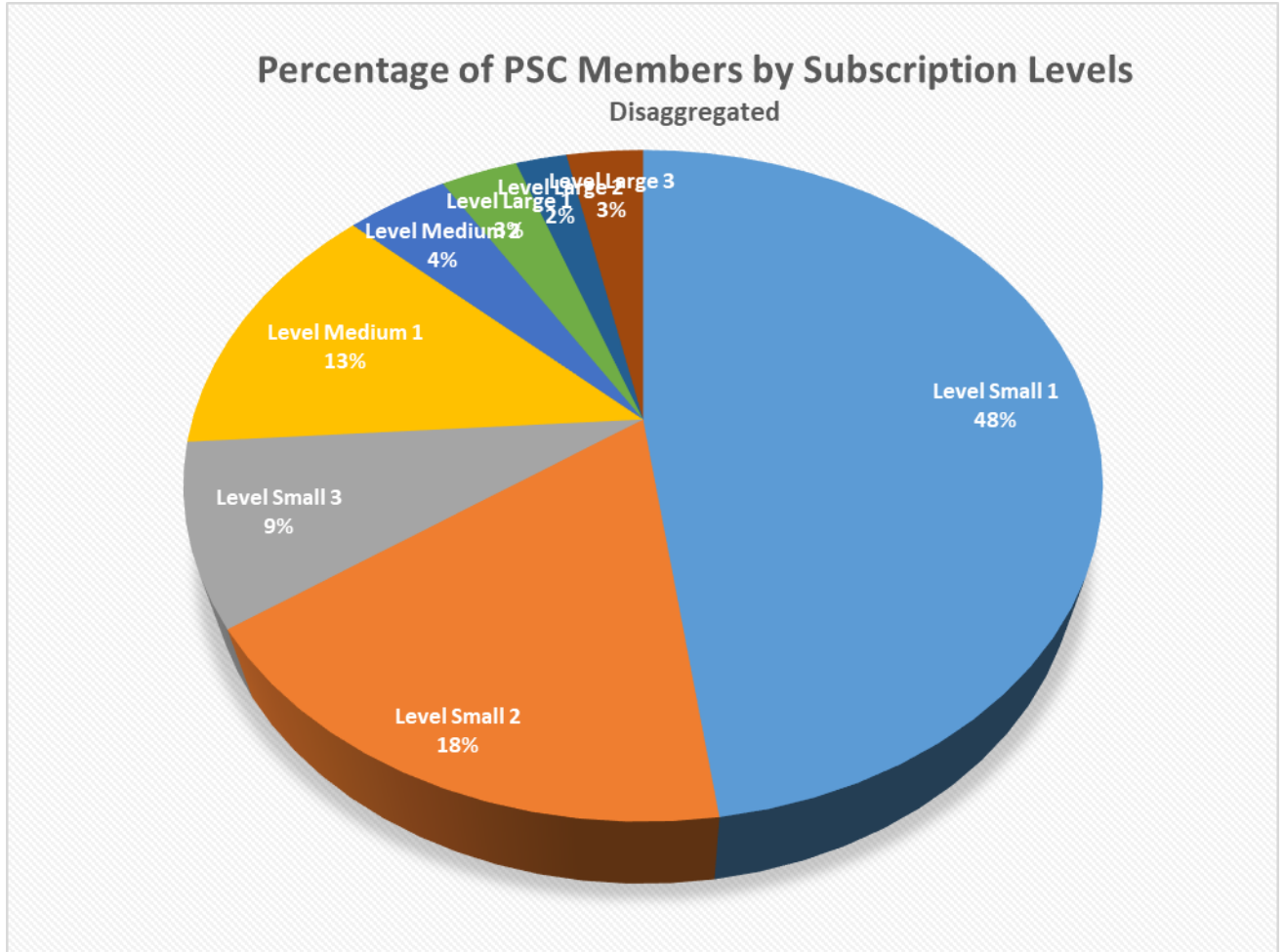


- 3 ICoCA Certification applications are currently under review.
