

# ICoCA Membership Update July-October 2018

## Overview

Since June 2018:

- The Secretariat has received 7 new applications (from Afghanistan, Albania, Cyprus, Iraq, Lebanon, Libya and Zimbabwe). One application was approved early October. The other applications are currently under review.
- 4 companies were approved as Members since June 2018 (from Afghanistan, Nigeria, Iraq and USA) (in total, 11companies became Members since January 2018).
- 5 Pakistani companies, including 1 ICoCA Certified Member, withdrew their Membership in July, August and September 2018 after the Ministry of Interior of the Government of Pakistan instructed all Pakistani companies to cease their registration with ICoCA.

<sup>&</sup>lt;sup>1</sup> In addition to the companies that withdrew in July and August 2018, and 5 companies had their Membership terminated earlier that year for non-payment of the 2017 Membership dues (from the UK, Turkey, Spain, China and Malta).

<sup>&</sup>lt;sup>2</sup> 3 companies received ICoCA certification on 22 May and 15 August 2018. In addition in August 2018, 1 ICoCA Certified Member withdrew and 1 other ICoCA Certified Member discontinued their external certification, making their ICoCA Certification unvalid. Finally, 3 companies received ICoCA Certification on 28 September 2018.



- 3 new applications for ICoCA Certification were received in July, and 1 in August (and were recommended and approved in September 2018).
- 5 ICoCA Certification applications are currently under review.
- o Type of services provided:
  - 50 Members operating on land;
  - 17 Members with maritime-based operations;
  - 27 Members with both maritime and land-based operations.
- 30 membership applications under review.


